**Summary:** The U.S. Embassy in Rabat is seeking eligible and qualified applicants for the position of Procurement Agent in the General Services Office (GSO).

The work schedule for this position is Full Time (40 hours per week)

**Start date:** Candidates must be able to begin working within a reasonable period of time (two months) of receipt of agency authorization and/or clearances/certifications or their candidacy may end.

**Supervisory Position:** No

**Duties:** The incumbent is responsible for purchases made by the U.S Embassy and associated agencies. Evaluates and approves vendors and authorizes purchase orders for goods or services in accordance with U.S. Government regulations. S/he should be familiar with a variety of the field's concepts, practices, and procedures. A wide degree of creativity and latitude is expected.

## Qualifications and Evaluations

**Education:** At least two years of college or university studies in general coursework is required.

## Requirements:

**Experience:** A minimum of two years of experience working with the US Government or other commercial enterprise providing experience with customer service, sales, and/or procurement/purchasing is required.

**JOB KNOWLEDGE:**

- Must have a good knowledge of local market practices and suppliers
- Knowledge of standard management, customer service and business procedures are required

**Evaluations:**

**Language:** Level III (Good Working Knowledge) Speaking, Reading, Writing English, Arabic and French is required. (Language proficiency will be will be tested)

**SKILLS AND ABILITIES:**

- Must be able to work independently and use creative problem-solving, depending on the circumstances.
- Must be persistent in pursuing solutions in response to normal bureaucratic inflexibility.
- Must be able to operate a personal computer including Windows, Excel, Access, and other programs
- Must be proficient in the use of the internet.
- Must be well-organized and able to prioritize.
- Must have a local driver's license category B.

**Qualifications:** All applicants under consideration will be required to pass medical and security certifications.

Failure to do so may result in a determination that the applicant is not eligible for a hiring preference.

- (2) AEFM / USEFM
- (3) FS on LWOP and CS with reemployment rights \*\*

\* **IMPORTANT:** Applicants who claim status as a preference-eligible U.S. Veteran must submit a copy of their most recent DD-214 ("Certificate of Release or Discharge from Active Duty"), equivalent documentation, or certification. A "certification" is any written document from the armed forces that certifies the service member is expected to be discharged or released from active duty service in the armed forces under honorable conditions within 120 days after the certification is submitted by the applicant. The certification letter should be on letterhead of the appropriate military branch of the service and contain (1) the military service dates including the expected discharge or release date; and (2) the character of service. Acceptable documentation must be submitted in order for the preference to be given.

\*\* This level of preference applies to all Foreign Service employees on LWOP and CS with re-employment rights back to their agency or bureau.
